**Gold Club Membership & Independent Distributor Agreement
Terms and Conditions**

Gold Club Members choosing to participate in our Discount & Bonus Program are considered Independent Contractors and are required to adhere to the following terms and conditions:

1. The Gold Club Member/Distributor warrants that he/she is of legal age within the state that he/she resides when entering this agreement with Rag Mops, Inc. dba The Trasan Network.
2. No purchase of product or literature has been required to become a Gold Club Member/Distributor other than the initial enrollment fee to cover administration costs and the Member's replicating website.
3. The status and position of the party(s) entering into this agreement is wholly that of an Independent Contractor, and shall not be construed to create a relationship of employer-employee, agency, partnership, or joint venture between any Member, Distributor, Referring Member and Rag Mops, Inc.
4. Only registered Gold Club Member/Distributor will have the exclusive right to sell products offered by Rag Mops, Inc. to a retail market and to refer other Gold Club Member/Distributors in accordance with current policies and procedures set forth by Rag Mops, Inc.
5. Gold Club Member/Distributor warrants that he/she will adhere to all federal, state, county, city, etc. laws pertaining to the selling or advertising of Rag Mops, Inc. (Trasan) products.
6. Gold Club Member/Distributor is solely and completely responsible for the declaration and payment of any and all local, state, and federal taxes, including sales taxes for any personal sales of Rag Mops, Inc. products.
7. Gold Club Member/Distributor may purchase products from their Referring Member or from Rag Mops, Inc. directly at the suggested retail price less the appropriate discount percentage as currently published by Rag Mops, Inc.
8. All purchases or orders are to be paid at the time the order is placed and in compliance with discounts, sales tax, etc. as currently published by Rag Mops, Inc.
9. Rag Mops, Inc.'s marketing plan is based on retail sales to the end consumer and thereby prohibits the buying of inventory for the purpose of qualifying for bonuses or advancement in the Discount and Bonus program. However, a reasonable amount of inventory for the purpose of conducting day-to-day business is acceptable.
10. Unsold inventory in new condition may be returned, freight prepaid, minus a 15% restocking fee within 30 days of termination of this agreement.
11. Gold Club Member/Distributor is not obligated to charge customers the suggested retail price on any personal sale.
12. Gold Club Member/Distributor may not use the name or trademark of TRASAN in any materials unless pre-approved by Rag Mops, Inc. and accompanied by the words, "Independent TRASAN Distributor", "Independent Distributor for TRASAN", or "TRASAN Independent Distributor". The term "Gold Club Member" may be substituted for "Distributor" in the before mentioned terminology.
13. General suggested media ads may be obtained from Rag Mops, Inc. and may be used by Gold Club Member/Distributor to develop business both through retail sales and referrals. The costs incurred in placing these ads with local media for publication is the complete responsibility of the Gold Club Member/Distributor.
14. Gold Club Member/Distributor warrants that he/she will represent Rag Mops, Inc. dba The Trasan Network® in a fair and honest manner and comply with company policies and procedures that are in effect through the "Rules of Conduct/Code of Ethics" as published along with changes that are made from time to time.
15. Gold Club Member/Distributor warrants that he/she will not misrepresent the company, its products, nor make any false claims regarding earnings or the marketing plan.

16. The term of the Rag Mops, Inc. Gold Club Membership and Independent Distributor Agreement shall be for a period of one year and is renewable each year thereafter during the anniversary month by paying an annual renewal fee. This action signals the Gold Club Member's/Distributor's intent to continue either as a Member and/or "retailing" the Rag Mops, Inc. product line and ensuring the income from their referral accomplishments. In paying this renewal fee, the Gold Club Member/Distributor agrees to abide by the rules, regulations, policies and procedures that are in effect at that time, as well as those changed or added during the following renewal year.

17. Gold Club Member/Distributor may cancel this agreement at any time and thereby resign his/her distributorship upon written notice to Rag Mops, Inc. All warranties stated in this agreement will survive termination.

18. Rag Mops, Inc. may terminate this agreement if the Gold Club Member/Distributor fails to comply with any of the terms or conditions set forth herein by giving written notice of the termination and the reasons for such action.

19. Rag Mops, Inc. Gold Club Member/Independent Distributor may not sell, transfer, or assign his/her distributorship without the written consent of Rag Mops, Inc. dba The Trasan Network®, which will be granted at the sole discretion of Rag Mops, Inc.

20. Gold Club Member/Distributor will indemnify Rag Mops, Inc. dba The Trasan Network® for any and all liability incurred by Rag Mops, Inc., including attorney's fees and costs, arising from or related to any breach of the warranties or terms of this agreement, the negligence or the intentional wrongful conduct of the Gold Club Member/Distributor. This indemnification obligation will survive the termination of this Agreement.

THIS AGREEMENT AND ANY OTHER CURRENTLY PUBLISHED TERMS CONSTITUTE THE ENTIRE AGREEMENT BETWEEN THE DISTRIBUTOR AND RAG MOPS, INCORPORATED.
